THE FOUNDATION IS DIRECTED BY A VOLUNTEER BOARD OF BUSINESS LEADERS AND CIVIC-MINDED FRIENDS OF THE UNIVERSITY. THE FOUNDATION SOLICITS FUNDS FOR A VARIETY OF PURPOSES CENTRAL TO THE HEALTH OF THE UNIVERSITY, INCLUDING STUDENT SCHOLARSHIPS (UNDERGRADUATE AND GRADUATE), LECTURESHIPS, EQUIPMENT, SPECIAL PROGRAMS AND NEW ACADEMIC INITIATIVES. THE FOUNDATION PROVIDES VITALLY NEEDED DOLLARS FOR A VARIETY OF PROJECTS AND PROGRAMS THAT ARE NOT FUNDED BY THE STATE BUDGET.
